With additional on-the-job EKG training or experience, you may specialize areas such as cardiac catheterization, Holter monitoring, phonocardiography, stress testing, and vectorcardiography. You should have an interest in high-tech mechanical equipment and be able to sympathize and reassure patients who are apprehensive about the testing procedure

CERTIFICATION EXAM ELIGIBILITY

Each certification body has its own eligibility requirements. Please make yourself familiar with these before applying for national certification testing. MedCerts sponsors certification but it is up to the student to ensure they meet eligibility requirements. The National Healthcareer Association (NHA) allows students to take their certification exam up to 12 months prior to graduation from high school and will issue a provisional certification upon passing the exam. To earn full certification after graduation, you must provide proof of graduation (high school diploma or GED) upon completion of meeting this requirement.

EXPERIENTIAL/CLINICAL COMPONENT:

Experiential/Clinical Component Requirements - This program has a clinical requirement of 10 live EKGs which must be completed within 180 days of passing the CET exam. Students are responsible for locating and securing a site to fulfill the clinical requirements of the program. MedCerts cannot guarantee placement to complete this clinical requirement. It is important to note that some clinical sites will not take on any clinical candidates under the age of 18. It is important for students to be aware of these requirements prior to taking their certification.

CRIMINAL BACKGROUND CHECKS AND DRUG SCREENING POLICY:

MedCerts does not perform criminal background checks, nor do we test students for illicit drug use. Please be advised that while MedCerts does not perform these checks, the student's drug, criminal, or immunization status may prevent clinical/externship placement and future employment as a healthcare or IT professionals. Candidates with a felony conviction are not eligible to participate in ANY MedCerts program that includes the Pharmacy Technician certification as a primary or secondary certification
